

PRIVACY

This privacy statement contains information on how S.I.P.R.E.S. S.R.L. Via del Santo 219, 35010 Limena (PD) ITALY will treat the personal information obtained through this website.

As referred to in article 13 of the Legislative Decree D.Lgs. n. 196/2003 (protection of personal data), this privacy statement concerns those who interact with the web services provided by S.I.P.R.E.S. This statement only concerns Kearr's website. Therefore, it does not cover links within this site to other websites.

This statement follows the Recommendation 2/2001, adopted on 17 May 2001 by the European authorities for the protection of personal data, as they met in the Working Party set up by article 29 of Directive 95/46/EC, in order to identify certain minimum requirements for collecting personal data on-line, and, in particular, the methods, times and nature of the information provided by data controllers to users, when they connect to websites, whatever the purposes of that connection.

THE DATA CONTROLLER

DATA PROCESSING LOCATION

Via del Santo 219, 35010 Limena (PD) and are only carried out by the technical staff of the Department in charge of processing, or by staff responsible for occasional maintenance operations. Personal information submitted to S.I.P.R.E.S. S.R.L. Via del Santo 219, 35010 Limena (PD) via this website will not be provided to any third parties.

Personal data provided by users requesting services or information via e-mail or making a complaint are processed to provide the service requested are disclosed to third parties only if necessary for this purpose.

TYPES OF DATA PROCESSED

Personal data collected by S.I.P.R.E.S. S.R.L. Via del Santo 219, 35010 Limena (PD) include: name, surname, geographical location, navigation data and email addresses, as well as data contained in e-mails.

During normal operations, information systems and software used for this website collect some personal information whose transmission is implicit in the use of Internet communication protocols.

Although not collected for the purpose of being associated with identified individuals, such kinds of information may by their nature allow users to be identified, if processed and associated with data held by third parties.

These kinds of data include IP addresses or domain names of the computers used by the visitors of the website, URI (Uniform Resource Identifier) addresses of the required resources, the request time, the method used to submit the request to the server, the size of the file sent in response, the numerical code that indicates the status of the server response (successful completion, error, etc.) and other parameters related to the user's operating system and computing environment.

These data are only used to provide anonymous statistical information about the use of the website and to check its proper functioning and are deleted immediately after processing. These data may be used to establish responsibility in case of computer-related crimes against this website. In all other circumstances, navigation data are not stored for more than seven days.

DATA VOLUNTARILY PROVIDED BY USERS

FREEDOM TO SUBMIT PERSONAL INFORMATION

DATA PROCESSING PROCEDURES

RIGHTS OF DATA SUBJECTS

Data subjects have the right to obtain confirmation of the existence of such data and to be informed about their content and origin, check their accuracy and request data to be integrated, updated or corrected (as laid down in article 7 of the Legislative Decree D.Lgs. n. 196/2003).

Under the terms of this article data subject have the right to request their data to be deleted, rendered anonymous or removed if unlawfully processed. They also have the right to deny, for legitimate reasons, their processing.
